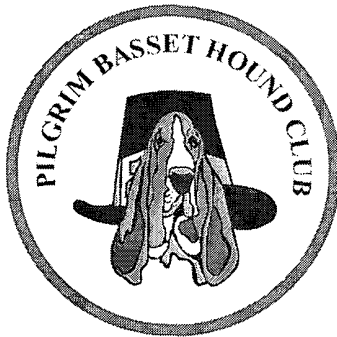

Bred by Exhibitor (BBE) Class Eligibility (revised 09/02):

- All dogs entered in the Bred by Exhibitor Class must be **individually registered** with the AKC.
- The person handling the dog must be a breeder of record of the dogs and an owner of record of the dog.
- To exhibit in this class, family members must be a breeder and owner of record.

Non-Regular Classes - Entry Fee \$18.00

(Involving Single Dog Entries)

Winners of these classes will be eligible to compete in Best of Breed Competition.

Field Trial Class - Class for dogs and class for bitches that have placed in an AKC Sanctioned Field Trial or that have been awarded a Judge's Award of Merit.

Veteran Class - Class for dogs and class for bitches that are 7 to 9 years old, class for dogs and class for bitches who are 9 years old and over on the day of the show.

Non-Regular Classes - Entry Fee \$18.00

(Involving Multiple Dog Entries)

As the judge's decision in the following classes is based on the merits of more than one dog or bitch, no one of the dogs or bitches judges first in these classes will be eligible to compete for Best of Breed by virtue of having won in these classes.

Stud Dog - For stud dogs and at least two of their get, but not more than four of their Get. Owner of the stud dog not necessarily be the owner of the Get. Stud dog must be entered in the stud dog class and must be shown in the ring with its Get. Get will only be judged on the basis of their merits. Each dog entered as a Get must be entered in a regular class, Best of Breed or some Non-Regular Class other than Stud Dog. NOTE: There is no additional fee to the Get for the Stud Dog Class.

Brood Bitch - Same as Stud Dog, substituting Brood Bitch for Stud Dog and produce for Get.

Chapter 11, Section 8 of the Dog Show Rules provides that a castrated dog or spayed bitch may be entered in the Stud Dog Class and Brood Bitch class respectively.

Brace - For two (2) dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two (2) handlers. Both dogs competing in brace must have at least one common owner.

SWEEPSTAKES

Puppy Sweepstakes - Entry Fee \$8.00

Puppy Sweepstakes is open to all Basset Hounds at least six (6) months and not yet 18 months of age who have not yet completed the requirements for Championship. Entries shall be made at the same time and on the same form as the regular classes. All dogs entered in sweepstakes must also be entered in regular class at the Regular Entry Fee. Any person may handle a dog in Sweepstakes. The amount of money received from entry fees in individual class, less 35% to defray expenses, will be divided in the class, rounded to the nearest dollar, as follows: First Prize 50%, Second Prize 25%, Third Prize 15%, Fourth Prize 10%.

Veteran Sweepstakes - Entry Fee \$8.00

Veteran Sweepstakes is open to all Basset Hounds who are 7 years of age and over on the day of the show. Entries shall be made at the same time and on the same form as regular classes. All dogs entered in Sweepstakes must also be entered in a Regular or Non-regular Class at the appropriate Entry Fee. Any person may handle a dog in Sweepstakes. Spayed bitches and neutered dogs may enter. The amount of money received from entry fees in individual class, less 35% to defray expenses will be divided in the class, rounded to the nearest dollar, as follows: First Prize 50%, Second Prize 25%, Third Prize 15%, Fourth Prize 10%.

OPEN JUNIOR CLASS: For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN INTERMEDIATE CLASS: For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN SENIOR CLASS: For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

Competition must exist for Best Junior Handler.

Admission & Parking: There is no admission fee or parking fee. There is no overnight parking.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
